5. PRODUCTION SURVEY REQUIREMENTS :

5.1 - The Loudspeakers: DP series, DPD series, CAR series, CAP-15T are to be manufactured, examined and tested by **Den Norske Hoyttalerfabrikk** in accordance with the type described in this certificate and Bureau Veritas Rules for the Classification of Steel Ships.
